The U.S. Army Corps of Engineers, Caribbean District (Corps) is beginning preparation of a National Environmental Policy Act (NEPA) assessment for a proposed flood damage reduction study initiated under the authority of Section 205 of the Flood Control Act of 1948 (P.L. 80-858). The purpose of this study is to identify flood risk management measures to reduce flood damages in the project area in Aibonito, Puerto Rico. Aibonito is located on the main island of Puerto Rico midway between San Juan and Ponce, and west of Cayey. The study will focus on the downtown area of the City of Aibonito. The Municipality of Aibonito is the Non-Federal Sponsor (NFS) for this study.

Within the study area, there are residential and commercial properties, bridges, forested areas, emergency services.

Section 205 of the Flood Control Act of 1948 provides authority for the Corps to carry out flood damage reduction studies in partnership with non-Federal government agencies, such as cities, counties, or units of state government. The purpose of this study is to (1) reduce risks to health and life safety from severe riverine flooding due to storms and (2) reduction of flood damages to infrastructure.

We invite the participation of Federal and state agencies, local agencies, interested parties, and individuals interested in providing comments and identifying any issues or concerns. We also welcome your views, comments, and information about environmental and cultural resources, study objectives, and important features within the described project area. Please share this notice with any interested party.




Figure 1. Map of the proposed project area.
